At 0052 hours police from the Ipswich District were advised by PolAir that a stolen vehicle was entering the district. This vehicle has been involved in a number of dangerous operations in the Brisbane and Logan area and PolAir had been actively tracking the vehicle fro approximately 3 hours. The vehicle has headed westbound on the Centenary Highway. Ipswich had multiple police vehicles in positions with TDDs available to stop the vehicle.

At 0104 hours, TDDs were used and were successful at the occurrence address. The vehicle did not stop and proceeded on the Centenary Highway heading west and then turned left onto Ipswich Boonah Road. The vehicle travelled on this road for approximately 12 kilometres, varying in speeds due to tyre loss. At 0115 hours, approval was given by the DDO to box the vehicle in if appropriate. 

The offender was travelling east on Marian Street turned north onto Trainor, turned east onto Ivy Street before turning right up onto the gutter through the carpark of SuperCheap Auto on the Corner of Marian and Trainor Streets. The offender has run the stop sign at the intersection of Trainor and Marian Street, turned left and headed in an eastlery direction on Marion Street follow by police. Offender failed to pull over when emergency lights were activiated and continued to travel at or around the speed limit in an easterly direction on Marion Street past the intersection of Abel Smith Parade before accelerating to approximately 80klms an hour. Offender continued travelling east despite police activating sirens and continued to travel along Marion Street doing approximately 80klms past the D'Agular before accelerating to approximately 100 klms an hour. Offender then continued to travel on the Barkly Highway in an easterly direction away from police and out of sight. After police terminated the intercept approximately 1 klms past the truck stop at Breakaway.

Police travelling west on Marion Street from the intersection of Kookaburra and Marian Street observed the nominated vehicle turn onto Trainor. Police turned north on Trainor Street and observed vehicle drive through the carpark and back onto Trainor Street directly past police. Police observed vehicle had a customised number plate black with white writing similar to that of a vehicle reported stolen on the 14/01/2016. Police have followed the vehicle and observed it run the stop sign. Police havehve activated emergency lights and followed after the vehicle in an attempt to intercept. At this time police were of suspicion was that the vehicle was stolen. When the vehicle has failed to pull over police have activated sirens. Police have noticed Comco of the vehicles failure to stop. Police conducted risk assessment, very light traffic, nil pedestrians, clear visibily, sunny /dry conditions, sealed road and dual lanes in good condition. Nil other relevant circumstances. Police observed the vehicle to travel east onto the Barkly Highway.
