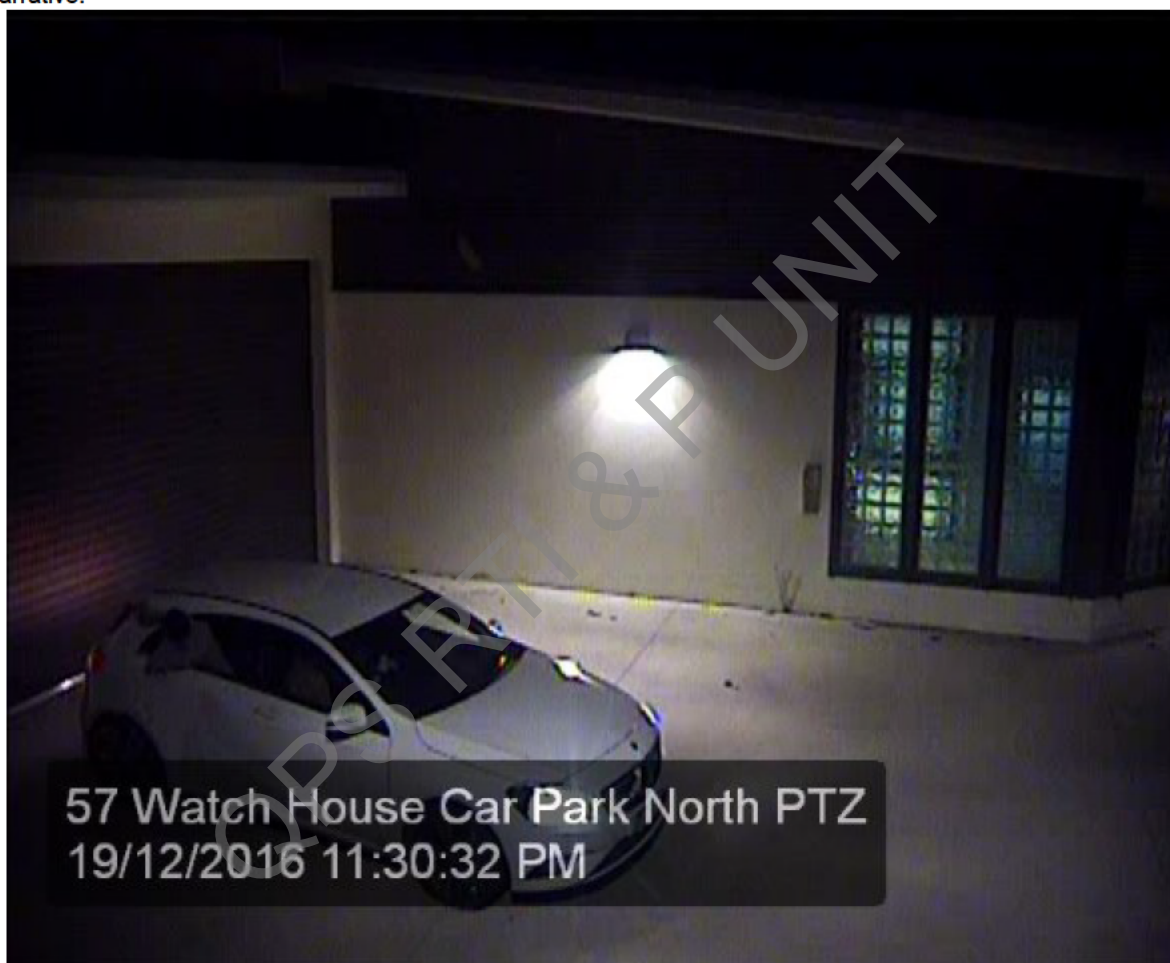

At an unknown time, unknown persons have cut a hole in the wire fence located at the rear of the holding yard situated at the rear of Edmonton Police Station. The unknown person/s have removed 2 motorbikes that had been seized and stored in the yard via the hole in the fence. The unknown persons have then walked them to the Fuller Park approx. 1km from the station. The unknown persons were disturbed by Police who were conducting patrols of the area and have abandoned them in the park before decamping on foot in an unknown direction.

GENERAL REPORT

On the 24th of January 2017 at about 0000hrs Police were conducting bail curfew checks in the vicinity of Shaft Street, Edmonton. They were approached by Sch4p4(6) who informed them that there were approx. 10-12 juvenile youths in Fuller Park and that they had 2 stolen motorbikes. Police conducted a walk-through of the park and heard a number of voices but were unable to locate the group described by the informants. Officers located the two motorbikes described by the informants. The police then located 2 females in the park, Sch4p4(6) – both known to the officers. They were spoken to in relation to the bikes however claimed not to know anything about the bikes or the other persons in the park. Police conducted a street-check of the two plus Sch4p4(6) who joined the two girls while police were speaking to them. Police pushed the bikes back to Edmonton Station where they were put inside the station. The officers then conducted a search of the holding yard and located a hole that had been cut into the wire fence. This hole was cut in such a location that it could be accessed from the neighbouring residence but would not be easily observed from either the residence or from the Police Station. The hole would have been large enough to remove the stolen bikes through. DDO and SOC were called out to attend and police conducted checks of the surrounds for means and direction by which the offenders would have de-camped. The most likely route would have taken the offenders through the carpark of the neighbouring licensed venue and it is possible that CCTV may be available of the offenders. CCTV from the station does not cover the section of the holding yard that was broken into. SOC have already attended - DDO has notified the relevant parties.. SOC Confirmation task to be sent.

On the 3rd day of January 2017 at approximately 5:35pm, the offender has attended the Yeppoon Police Station to see his brother who was in Police custody. At this time, the offender has begun banging on the front glass door of the Police Station. Police have advised the offender that such behaviour was unnecessary and not to continue. Due to the offenders belligerent behaviour, Police have advised the offender that his brother would be released shortly and he would have to wait outside. The offender has proceeded to the side of the Police Station, into the vehicle bay and begun aggressively banging on the side entrance door, restricted to Police and authorised personnel only. Police have once again calmly spoken with the offender who has stated to Police, "Why don't you just tell me what the fuck is going on you fucking arrogant cunt!" Police have told the offender that such language was not necessary, The offender has begun pushing his chest out and clenching his fists, saying, "Well if you just tell me whats fucking going on, then I will know." Police have attempted to advise the offender of his brothers current health problems and why the Ambulance was required. The offender continued to be belligerent with Police, attempting to come into the Police Station after being told he was not allowed too. The offender has been told to leave and wait out the front. The offender has walked past an Emergency Shower located in the vehicle bay and turned it on, causing water to flow at high speed from the shower. The offender has left this on and proceeded to leave the vehicle bay screaming, "Fucking cunts!"

Police have arrested the offender at the front of the station and proceeded to walk him through to the station holding cell.
