CREEK REST STOP TURN RIGHT INTO FORRESTRY ROAD THORNHILL STATION IS ON THE LEFT HAND SIDE ENTER THE PROPERTY & TRAVEL SOOMTRS ON A DIRT ROAD

301 approx 60 indigenous people arguing with each other - extra crews are required at priority to back up generals crew GL301.

1022hrs WHITEHEAD.Liz - SGT HARMS transferred to T302 BOWDEN's mobile currently deployed at Kolan River.

1022hrs WHITEHEAD.Liz - 256 authorised code 2 from Tannum Stn

1023hrs WHITEHEAD.Liz - 301 advises approx 60 people involved

1023hrs WHITEHEAD.Liz - 207 proceeding code 3 at this stage.

1024hrs WHITEHEAD.Liz - 301 SITREP advises crews to turn their lights & sirens off once approaching the location as persons are likely to go off.

1026hrs WHITEHEAD.Liz - 256 confirmed code 2 from Tannum stn.
