At 1800hrs on the 12/01/2017 police were called to the occurrence address in regards to a disturbance between 6 ATSI males. Upon arrival police took up with a group of males, including the two offenders. All males issued move on directions. The two offenders became aggressive and began swearing at police and yelling to each other. At this time many members of the public were using the park and both offenders failed to adhere to warnings to stop disorderly behaviour. Both offenders arrested for public nuisance. During search of [Sch4p4] he declared he was in possession of a used syringe and needle (located in his left pant pocket) and a knife (located in his duffel bag). During search of [Sch4p] he turned his head towards VICTIM [Sch4p4(6)] and spat saliva towards him. Saliva missed Victim [Sch4p4(6)] head by approx 5cm.

#### GENERAL REPORT

Offence as per MO Victim [Sch4p4(6)] was on duty and in full uniform at the time of the assault. Performing official duties (searching offender in custody) Body worn video operational by all police present, including victim [Sch4p4(6)]. Offender [Sch4p] stated to victim [Sch4p4(6)] he is infected with Golden Staph Photographs of saliva on the roadway taken by Action Officer [Sch4p4]. After the attempted assault, Offender [Sch4p] was restrained and during this a rear window of the police vehicle was damaged. Photographs taken by Victim [Sch4p4(6)]. Photographs of syringe taken and properly disposed of by [Sch4p4]. Photograph taken of knife by [Sch4p4]. No banning notices as offence occurred outside SNP. No need for forensic examination as the serious assault is an attempted offence only and no saliva landed on Victim [Sch4p4(6)]. The act of spitting was captured on victim's body worn video. Offenders transported to Brisbane Watch House and charged. . SOC not required.

The offence location is a single story dwelling with large living area in the middle of the house.

The offender had taken an overdose anti-depressants and anxiety as he stated he wanted to kill himself. QAS had attended and spoken to the offender at length at which time the offender has turned aggressive and stated he will not go to the hospital without a fight. Police were called by QAS and attended. At this time the offender had barricaded himself into the bathroom of the house. A short time later the offender has exited the bathroom and returned to the living area. Police have approached the offender and explained that he was detained under the MH ACT and needed to go to the hospital. The offender kept saying that he would punch anyone who touched him and he just wanted to die at home. Police have grabbed the offender and scuffle has broken out. During this scuffle the offender has punched the victim to the face a number of times. The offender was then restrained and pinned to the ground before being moved to the stretcher and taken to the GCUH for treatment.

**GENERAL REPORT**

As per the MO.

Police were staged with QAS at the front of the house based on the information that they had provided. The front door was open and a clear line of sight could be made into the house. The offender has been seen to walk across the lounge room. At this time Police and QAS have entered the house and began speaking with the offender. The offender kept repeating that should anyone touch him that he will punch that person/s. Police have attempted to talk the offender down however this was getting nowhere. The offender was warned that should he not comply he may be tasered. The offender was not bothered by this. Constable [Sch4p4(6)] has advised the offender that he was detained under the Mental Health Act for the purpose of an EEO. The offender continued to make threats of assault if anyone approached and was non-compliant with police requests. Constable [Sch4p4(6)] then moved to restrain the offender attempting to use OST restraining techniques by grabbing at the offenders arm. The offender has resisted pulling away from Constable [Sch4p4(6)]. The offender has then begun to strike at Constable [Sch4p4(6)] with both fists which is when the scuffle/serious assault has taken place. Assisting Officer and QAS have assisted in attempting to gain control of the offender. During the scuffle both police officers have drawn their tasers and warned the offender. During this warning the QAS officers have been able to gain control of the offender and police holstered their tasers and have managed to hold the offender down on the floor until extra Police units were on scene. The offender was eventually controlled and pinned to the ground.

After the scuffle it was realized that Constable [Sch4p4(6)] was injured. QAS examined Constable [Sch4p4(6)] at the scene and transported him to Hospital for assessment. At the time of completing this occurrence injuries are unclear.
