The victim's injuries are: left hand ring finger puncture swollen bruising. Sch 4p4(6)

At the nominated date and time the offender has been walking down the Brunswick Street Mall towards Wickham Street. The offender was walking by himself yelling out abuse and screaming at no one in particular. As he has walked past police he has yelled out ?what the fuck are you looking at?? repeatedly and tried to bait police into engaging with him. Further down Brunswick St he has then abused a member of the public and tried to instigate a physical fight. Police have taken up with the offender outside Valley Ink where he was arrested. While walking to the Police Beat the offender has tensed up and began to resist. Police have repeatedly told the offender to stop resisting but he has continued to fight and a physical altercation with police has ensued outside the police beat. The offender was transitioned to the ground and restrained. Police assisted the offender to his feet to walk him into the police beat. As the offender got to his feet he looked in the direction of one of the police officers and moved his head back in a motion to spit. Another police officer has then placed her hand across his face to prevent him from spitting. The offender has then bitten down hard of the police officers finger.
