Natasha

The following information is in relation to organising QCS to take over the guard of a prisoner at one of Brisbane's three tertiary hospitals. The prisoners can be either sentenced or remanded in custody but must be admitted to the hospital (as opposed to being in A&E).

**PA Hospital Secure Unit**

Queensland Corrective Services (QCS) has a number of beds in a secure ward at the Princess Alexandra Hospital (PAH). This is known as the PA Hospital Secure Unit (PAHSU)

These beds are only available to prisoners that:

1. Have been admitted to hospital;
2. Are remanded in custody or sentenced; and
3. Can lawfully be accepted by QCS (have a Verdict and Judgment Record (VJR))

Beds in the secure ward are not available to the Queensland Police Service (QPS) while prisoners remain in the custody of QPS, either on an objection to bail or have not been accepted by QCS. QCS will not take over the guard of a prisoner in a hospital while the prisoner/patient remains a QPS responsibility i.e. objection to bail.

QCS have a process for admitting prisoners to the secure ward, this process ensures that prisoners are lawfully in the custody of QCS and the appropriate use of beds in the secure ward. QCS staff working in the secure ward are not able to accept prisoners directly from the QPS.

The Inspector Brisbane City Watchhouse (BCWH) or Senior Sergeant Officer-in-Charge BCWH are responsible for making arrangements for prisoners to be accepted into the PAHSU. QCS will also endeavour to provide staff to guard prisoners that have been admitted to a ward and there is no room in the secure unit.

It is requested that contact with QCS and QH staff in the Secure Ward of the PA Hospital relating to bed availability should cease immediately;

**PROCEDURE FOR REQUESTING QCS TO ADMIT A PRISONER TO THE PA SECURE WARD OR TAKE OVER A GUARD IN A TERTIARY HOSPITAL**

- An email is sent to the email groups - *OIC Brisbane Watchhouse* and *Inspector Watchhouse Brisbane* with the following:
  1. A clear scanned copy of the current VJR
  2. Current hospital location – floor, ward and contact number for that location
  3. Clear indication of medical issue and future prognosis
  4. Date and time prisoner was taken into custody
- Phone contact is made with the Inspector, BCWH or S/Sgt OIC BCWH



- BCWH will make the necessary inquiries with QCS and advise accordingly.

### **Tertiary Hospital - RBH and Prince Charles hospitals**

If you have a prisoner being guarded in one of Brisbane's other tertiary hospitals (RBH or Prince Charles hospitals) the same procedure must be used to request QCS to take over the guard.

### **Non-tertiary hospitals (Redland, Redcliffe, Caboolture, Logan, Ipswich etc)**

If a prisoner has been admitted to a non-tertiary hospital (Logan Redlands, Redcliffe, Caboolture etc) than that hospital has to make arrangements with the PA Hospital for an inter-hospital transfer. This is not an easy process and normally runs conjointly with the QCS process. i.e. the PA Hospital generally won't accept a prisoner/patient from another hospital unless QCS can guarantee a bed in the PAHSU.

### **CONSIDERATIONS**

- QCS are under no legislative obligation to take custody of prisoners/patients, this is a gentlemen's agreement.
- Generally, QCS will only accept prisoners into the secure ward if notification occurs prior to 12pm on a business day. Early requests (before 12pm) usually afford custodial transfers by end of day but there is no guarantee.
- QCS will often not accept prisoners if the VJR expires the following day or a couple of days later.
- QCS is unlikely to accept a prisoner/patient if they are being discharged from hospital the following day.
- When deciding the appropriate time to effect the arrest of an offender with known medical conditions, officers should consider the impact on frontline police potentially having to guard the prisoner in hospital (e.g. if a person with known health issues, requiring hospitalisation, is arrested on a RTP warrant on a Friday afternoon then QPS will be responsible for guarding until Monday).
- BCWH are unlikely to have the capacity to guard a prisoner in hospital. This may be the responsibility of the Patrol Group or Command that effected the arrest.
- Currently prisoners remanded in custody (as opposed to those sentenced) are the responsibility of the Arthur Gorrie Correctional Centre (AGCC) which is a privately run prison. On occasions more time is required to arrange for guards from AGCC to take over the guard.
- Consideration should also be given to creating an LCAD Job to allow officers guarding the prisoner/patient the ability to update the job on their QLite with relevant updates.

Good afternoon

A new floater overtime list has been placed on the Shift Supervisors desk up to and including 24<sup>th</sup> of May 2019 which is up to the end of the current roster period. If you wish to apply for any continuation of duty overtime during this period please nominate your shift times and forward to your supervisor as soon as possible so that we are able to project staffing numbers. This will allow officers being notified of their successful application in a timely manner.

If the shifts are not being filled the EOI will then be sent out to external Districts to assist in filling this overtime.

If you are on an RDO or PDO you can apply for 8hrs overtime (6a-10a + 10a-2p) or the 6hrs overtime (2p-8p). If 6am is too early to commence due to coming off shift or personal circumstances we will accept you to commence the overtime at 8am, giving you 6hrs overtime (8am-2pm).

### **EOI – CONTINUATION OF SHIFT OVERTIME**

In relation to the overtime shifts within the juvenile wings and officers from outside areas/units coming into the Watchhouse (some officers having limited experience in Watchhouse duties) a trial is being considered to allow officers within the BCWH to work continuation of shift overtime (4hrs).

This overtime will allow for a trained Watchhouse officer to roam between the juvenile wings and assist and provide instruction to these officers.

**The hours being trialled are:**

**6a-10a** (continuation of night shift)

**10a-2p** (commence overtime prior to 2p-10p shift)

**2p-8p** (continuation of 6a-2p day shift) – **during this shift you MUST make up clothing packs, if you do not want to complete this task don't apply for this overtime shift**

**This overtime relates specifically to the juvenile wings.**

Any officer interested in this overtime is to express their interest to their Senior Sergeant. Officers who are interested in working this overtime **MUST** meet Fatigue Management Requirements and have approval from their Senior Sergeant.

**Officers interested in this overtime are to forward this email along with their expressions of shift dates and times to their S/Sgt who will then either approve or not approve. S/Sgt's will then forward to me.**

When expressing your interest in this overtime and seeking your Senior Sergeant's approval, you **MUST** disclose any sick leave you have had within a 2 week period before the overtime commences. If you have had sick leave within that 2 week period, overtime approval **MUST** be sought from the OIC Brisbane Watchhouse.

Please also note that this overtime does not prevent you from expressing interest in any other overtime in the juvenile wings or juvenile transports.

## There are immediate solutions available to remove children from watch houses

As of 10.30 yesterday morning, there were 79 children in watch houses across Queensland. These children were as young as 10.

Queensland Public Guardian Natalie Siegel-Brown has been strongly advocating for the removal of children from watch houses for over 14 months, continually highlighting how the conditions violate their basic human rights.

“I have visited the Brisbane watch house, and seen with my own eyes children who are cold, who are hungry, who haven’t accessed any real outdoor air for two weeks or more, and who have little or no access to education. Some are being held in these conditions for weeks at a time.” Ms Siegel-Brown said.

Ms Siegel-Brown acknowledges that the issues giving rise to this situation are complex, but states that we cannot wait any longer to take action.

“There are solutions available right now, which I have already recommended to Government.

The solutions that would provide immediate change include:

- Temporary, immediate accommodation at youth detention centres. While temporary structures are certainly not ideal, anything has to be better than the travesty of holding kids in the conditions of a watch house.
- Transporting kids from the watch house each day to and from Brisbane Youth Detention centre, where they can at least access fresh air, proper health care, appropriate education and psychological support.

“At very least, we need to regulate how kids are managed in a watch house – so that they have the same human rights as kids are under youth justice legislation. This means rules around using isolation, access to family and all the basics that we require in a youth detention centre.” Ms Siegel-Brown said.

“Remember, these are children as young as 10 or 11. Almost none have been convicted of a crime – they are simply on remand. Many of them have no place to be bailed because they are homeless – or because we as a society have failed to take care of our children.”

“In many cases their charges are minor. I am seeing children being held in watch houses for days for crimes as small as shoplifting. Many are facing charges for what could only be called survival crimes.” Ms Siegel-Brown said.

“I do know that many communities are impacted by youth crime. However as a society we need to acknowledge and tackle the issues facing many of these children. Labelling these kids as criminals only makes a crime of their trauma, of their disability, of their suffering.”

“But we have to ask ourselves: How can *any* crime ever justify holding a child in these conditions?”

“We also need to look beyond recriminations and navel gazing and focus on the immediate restoration of these children’s human rights. Because no child should ever be held in a watch house. Period.”

Wanted to share with you another good news story from BCWH.

Yesterday we had 2 YPs turn 18 whilst in custody with us, Sch3(12) .

Throughout the day, the entire YJ team visited both at separate times, and with the permission of the Wing Operators, were able to see the boys face to face in the pod area. We sang Happy Birthday VERY loudly as we presented them with their birthday cupcakes. The other YPs in the wings joined in the singing with us. Both claimed it was "shame", but their faces said a different story. They were both so very appreciative to the staff.

Towards the evening, Sch3(12) had mentioned a few times that he wished he was out so he could go to the clubs for his 18<sup>th</sup>. With this in mind, I went and sourced some glow sticks, and at 1930 lockdown, we again gained permission from the wing operators, and "took the club to the boys" – we played some party music while YJ staff danced in the pods covered in glow sticks. All of the YPs in

the wings were joining in, and Sch3( in particular absolutely loved it and danced up a storm inside his cell. He buzzed us on the intercom at the end of shift and verbally showed his appreciation (words to the effect of "Thank you to everybody in there that made my day"), and Sch3 commented "I wasn't expecting this".

I want to personally thank all the staff on yesterday. Moments like these at BCWH are what make the job worthwhile and remind us why we keep coming to work with these YPs. That small spark of joy you brought them has created a memory that will remain with them forever. They need us in here more than you know, and you have a much larger effect on them than you sometimes realise. Special thanks also to WOC Michael Gardiner, WOC Craig Belsham, WWA QPS officer Michelle and WWA QPS officer Su-lee Jarrett for accommodating YJ staff requests to make these boys birthdays as enjoyable for them as possible. If anyone in an official capacity wishes to pass this positive feedback along to QPS please do.

Thanks again team, it's a pleasure to work alongside you all.
