Comments: Whilst tracking north to previous job P2 was lasered from a dwelling some distance away. Numerous exposures and for about 20 seconds. Unable to get a location on the offender due to the lateral distance and the requirement to get to urgent tasking.

At completion of task, conducted with P1, both aircraft were again struck from the same location with multiple laser strikes. Investigation revealed that the offender was a juvenile approximately 5c years old who was using a green laser to point at aircraft whilst jumping on a trampoline. P1 unable to remain overhead due to fuel limitations so P2 remained overhead and once obtaining footage activated the red/blue strobes and used Trakka to encourage the child to desist. P2 then remained overhead until MS361 were able to arrive on scene and speak to the child and his parents.

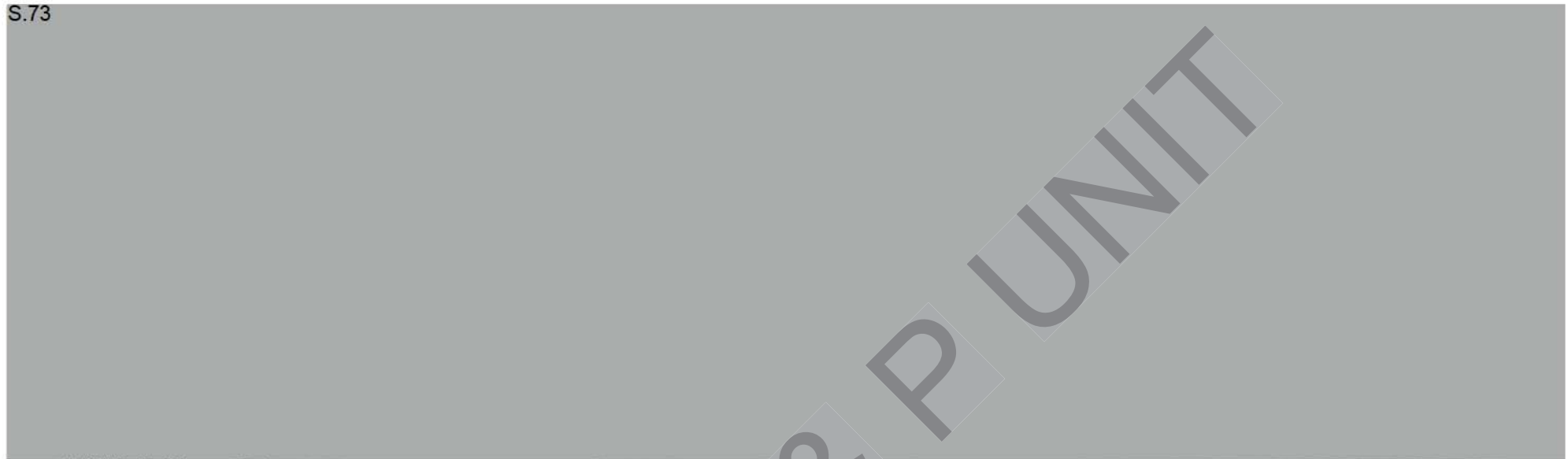

Comments: Conduct high visibility patrols in the Beenleigh / Eagleby area following numerous incidents, over the past month, of commercial passenger jets being lasered from the area. Struck by green laser on three seperate occasions however nil incapacitation suffered by aircrew. Origin of beam narrowed down to approx 300m radius, but nil further strikes prevented identification of actual offender. ATC notified of incident. Remained in area to attempt to locate offender without success. Patrols of area to continue until offender identified.

Comments: POLAIR 42 was struck with a green laser being shone in the vicinity of Sch4p4(6) for approximately 15 seconds whilst the aircraft was conducting orbits searching for a wanted person at Sch4p4(6). POLAIR 42 was at 1500' with nav lights and anti-collision lights activated. Camera slaved to the location of the lights and observed a male in the rear yard wearing a long sleeved shirt and underpants. Male was seen with a cylindrical object in his hand before going back inside.

ZS753 and 769 attended the address and the male matching the description answered the door Sch4p4(6)
