(a) Blank Fire Firearms

Select the categories of weapons you wish to apply for, by crossing the respective box(es)

Letter of Authorisation — A current dated signed letter of authorisation from the organisation which you represent, which includes full description of the activities for which category of weapon(s) are required.

If you are applying or renewing as an organisation, you are to also provide a copy of the business/company name providing details of the type of enterprise (e.g. sole provider, partnership, etc.) including the extract detailing the office holders of the company / business.

(Note: A Blank Fire Firearms licence may only be issued for the purpose of theatrical production, for starting sporting events or gun dog retrieval clubs).

(b) Military Re-Enactment or Historical Demonstration

Select the categories of weapons you wish to apply for, by crossing the respective box(es)

Financial — Military Re-Enactment — Proof of current financial membership of a recognised military re-enactment club / society. This proof is to clearly state your name and the expiry date of the membership, category(ies) of weapons required and must only be for the category(ies) of the weapon endorsed on your weapons licence.

(c) Group Licence (Shooting Club)

Select the categories of weapons you wish to apply for, by crossing the respective box(es)

Group Storage — Details of storage facility where weapons are to be stored, and its compliance with legislation.

Group Club Approval — Copy of the approved shooting club permit.

Group Letter — Club — A current and signed letter on club letterhead containing the following information:

- (a) The position held by the author of the letter in the shooting club.
- (b) Authorisation for the applicant to be a representative for this application.
- (c) The Categories of firearms required for this licence and details of activities which warrant the use of a firearm.

(d) Group Licence (Occupational)

E.g. Council / Pastoral / Airport

Group Storage — Details of storage facility where weapons are to be stored, and it’s compliance with legislation.

Group Business Extract — A Copy of the current registered business / company name providing details of the type of enterprise (e.g. sole trader, partnership., etc.) including the extract detailing the office holders of the company/ business.

If the applicant is a shooting gallery operator, also provide a copy of the shooting gallery approval number.

Group Letter — Occupational — A current and signed letter on company letterhead containing the following information:

- (a) The position held by the author of the letter in the company.
- (b) Authorisation for the applicant to be a representative for this application.
- (c) Details of activities which warrant the use weapons and the category(ies) of the weapons the licence requires.

(e) Historical, Military, Martial Arts (Miscellaneous)

Select the categories of weapons you wish to apply for, by crossing the respective box(es)

Weapons Description — A current and signed letter from the martial arts organisation detailing the description of the weapon(s) used by the organisation, also when and where the weapon(s) will be physically possessed.

Historical, Military or Martial Arts — Proof of current membership of a club that:

- (a) is, or affiliated with, a state, national or international historical, military re-enactment organisation, or martial arts organisation; or
- (b) is a genuine historical, military re-enactment organisation or martial arts organisation that gives training in the use of the type of weapon(s).

(f) Special Occupational (Miscellaneous)

Select the categories of weapons you wish to apply for, by crossing the respective box(es)

E

Weapon Description — A current signed letter from a martial arts organisation detailing the description of the weapon(s) used by the organisation, also when and where the weapon(s) will be physically possessed.

Specific Need — Written details of the special occupational need, or the exceptional need for self-preservation that cannot be satisfied in any other way.

Outline of conduct and duties — A signed and current letter on business letterhead verifying:

- (a) the reason(s) why the weapons are necessary;
- (b) the position held by the applicant;
- (c) the category of weapon required to use; and
- (d) the nature of the duties undertaken in the conduct of your business / occupation.
