(b) lessee of the property (valid proof, only if applying for Primary Production), must provide a copy of the lease agreement for property(ies); or
(c) manager of the property, must provide a copy of the employment contract as manager and can act on the owner / lessee's behalf on the property(ies).
Please note: This information is required for each property you intend on utilising weapons as part of your occupational need.
