THE PROPERTY CONTAINS 4 LARGE SINGLE STOREY COLOUR BOND CONSTRUCTION SHEDS APPROXIMATELY 100-150M LONG WHICH ARE NORMALLY UTILISED AS POULTRY FREE RANGE EGG SHEDS. THE FACILITY HAS BEEN NON-OPERATIONAL SINCE THE 20/06/2019 WITH NO POULTRY ON SITE WHILST CLEANING OF THE SHEDS AND OTHER GENERAL MAINTENANCE IS TAKING PLACE. AT 3:10PM 02/07/2019 CLEANING CONTRACTORS, Sch4p4(6) AND Sch4p4(6) WERE IN ONE OF THE CHICKEN SHEDS UTILISING A WATER PRESSURE SPRAY TO CLEAN THE SHED. Sch4p4(6) Sch4p4(6) WAS ALSO PRESENT. THE CLEANING INVOLVED THE USE OF A TRAILER WITH 2 X WATER PUMPS, FUEL TANK AND A 1000L WATER TANK ON THE TRAILER. THE TRAILER WAS LOCATED WITHIN THE SHED ON THE EASTERN EXTREME END. Sch4p4(6) ATTEMPTED TO TURN ONE OF THE PUMPS OFF DURING CLEANING, WHICH RESULTED IN SOME FORM OF ELECTRICAL FAULT AND THE PUMP SPARKED/FLAMED, IGNITING OTHER LINES ON THE TRAILER AND THE FUEL TANK. CONTRACTORS RAN TO NEIGHBOURING SHEDS AND OBTAINED FIRE EXTINGUISHERS, HOWEVER FIRE HAD MOVED INTO ROOF OF SHED AND THEIR SUPPRESSION EFFORTS WERE INEFFECTIVE. ROOF INSULATION AND RUBBER MATTING THROUGHOUT SHED FUELLED FIRE WHICH CONTINUED WEST THROUGH SHED, DESTROYING THE STRUCTURE INTERIOR.

Narrative:

The offence location is a rural farm property owned by the victim business Baiada Poultry Pty Ltd. The property contains 4 large single storey colour bond construction sheds approximately 100-150m long which are normally utilised as poultry free range egg sheds. The facility has been non-operational since the 20/06/2019 with no poultry on site whilst cleaning of the sheds and other general maintenance is taking place. At 3:10pm 02/07/2019 cleaning contractors Sch4p4(6) and Sch4p4(6) were in one of the chicken sheds utilising a water pressure spray to clean the shed. Sch4p4(6) was also present. The cleaning involved the use of a trailer with 2 x water pumps, fuel tank and a 1000l water tank on the

trailer. The trailer was located within the shed on the eastern extreme end. Sch4p4(6) attempted to turn one of the pumps off during cleaning, which resulted in some form of electrical fault and the pump sparked/flamed, igniting other lines on the trailer and the fuel tank. Contractors ran to neighbouring sheds and obtained fire extinguishers, however fire had moved into roof of shed and their suppression efforts were ineffective. Roof insulation and rubber matting throughout shed fuelled fire which continued west through shed, destroying the structure interior.

Fire report MO details

Fire moved into roof cavity of shed and ignited material curtains, insulation and rubber matting through the shed. Fire continued west through shed to other end of structure. . Fire suppression activity: QFES - Fire extinguished rapidly by QFES after fuel had been consumed..
