

On 10/08/2022, Forensic Officer 4038203 AUSTIN - CNS NR FNA SOC conducted a forensic examination at Maranol's Service Station, Queen St, Edmonton. Forensic Register Number FR2141569 refers.

A Red 2021 Bobcat Excavator Earthmoving Equipment QLD Reg #93906C was examined and the following exhibits were collected.

INFORMATION

T2203809447 received. Attended job address and TUW workmen for Clarke Civils NQ on the construction site. They advised that offender has used unknown implement to break a side window of the excavator. They have opened another window from the inside and stolen a fire extinguisher from inside. They have used the extinguisher and then dropped it on the ground nearby. They have put various graffiti tags in dust on the windows of the excavator. No other physical evidence was left behind.

OBSERVATION

The site is on the side of Bruce Highway off Queen Street, where there is Marano's Fuel Station. There were numerous excavators present at this location. The subject vehicle had a broken side window, and there was glass scattered throughout the cab. There were various graffiti tags made in the dust on the windows of the excavator. There were visible ridge detail evident in dust/mud on various parts of the excavator (windows and door). There was a small red fire extinguisher on the ground nearby the excavator.

EXAMINATION

General photographs were taken of the job address, including the damage. A fingerprint examination was conducted on the fire extinguisher. The excavator itself did not require a fingerprint examination as ridge detail was made in the dust/mud. 4 x fingerprints were observed and photographed, as listed. Nil biological evidence was identified.
