11:15hrs, RTI/40446 police from Rockhampton Station were detailed to attend CAD incident 1628-12122021 in relation to a group of persons crashing into another vehicle and attempting to steal another before decamping on foot towards the Mazda car dealership located on Musgrave Street, ROCKHAMPTON. On arrival police have observed Sch3(12) with QLD registration Sch4p4(6) in the taxi rank of the Northside Plaza Shopping Centre, outside of the CQ Medical Centre with extensive damage to the rear of the vehicle. Police further observed extensive damage to the victim Sch4p4(6) vehicle, a taxi with QLD registration T54876 along the full length of the right-hand side of the vehicle. Scene Observation
