Incident details:

The victim states that someone has gained access to the warehouse area and stolen 3 vehicles. The victim believes that entry has not been forced Sch4p4(6)

The offender/s have gained entry to the facility and gone straight to the office where the locked key box was, to remove several sets of keys and the vehicles.

The offender/s have moved a Commuter bus in order to remove the vehicles from the warehouse.

At some point during the offence a Mercedes Sprinter van was moved to outside the shed for around an hour at 22:30 overnight before being moved back and locked and secured.

CCTV footage has been reviewed which shows an old blue range rover (often at the complex) arrived at 19:51. Guys goes to gate at 20:09, a girl goes out to the gate as well, then late model Golf arrived 20:10. At 20:27 tattooed guy walked out to gate and waves another car in.

The offence location is a factory/warehouse and office space in an gated industrial complex. There are no witnesses

The complex is an industrial complex and after hours the complex gates are locked and secured and can only be
accessed using a 'remote' that each tenant is in possession of.

It appears that the offenders have used the remote to enter the locked gate in order to commit the offence and
when leaving the premises have again used the remote to open the gate to drive the stolen motor vehicle's out of the
premises. This is evident on CCTV footage that presumably a remote is used because as the vehicles approach the
gate, the gate opens.

Sch4p4(6) stated that no forced entry has been made to the business premises Sch4p4(6)

Once offenders have entered into the premises they have proceeded to the office area and within a cupboard is a
"lock box" containing vehicle keys. Sch4p4(6)

There is no forced entry to the lock box, therefore it is presumed a key was used to open the lock box and remove
the vehicle keys in order to steal the motor vehicles.

The premises is a large ware house with all the nominated stolen vehicles have been parked within the ware house.
The offenders have then used the vehicle keys from the lock box to enter into the vehicles and steal the said motor
vehicles.

BODY CORPORATE CCTV FOOTAGE

0220hours 07/12/2021 - silver Holden Colorado utility (unknown reg) enters the premises via the gate -
presumably uses a remote - the gate closes behind the vehicle once it enters. Unknown where the utility
goes within the complex.

0239hours 07/12/2021 - a silver sedan (unknown make or model) approaches the gate - opens the gate -
presumably uses a remote - and following behind is the stolen - Mini Cooper, Holden Commodore and
Holden Monaro

Body Corporate has provided Fob/Remote access log which shows User 024 entering numerous times
between 8:00pm on 06/12/2021 through to 2:43am on 07/12/2021

In particular there is a Gate Remote Activation by User 024 at 0215hours and 0223hours and further again
at 0242hours - with the exception of minor time difference between reader and CCTV.

On 7/12/21 three vehicles were stolen from unit 14/38 Kendor Street, Arundel. These three vehicles were in convoy with another vehicle a silver Holden Caprice with a black bonnet. The vehicles were stolen by using a remote control to open the front gate and there was also no damage to the business suggesting that the offenders were able to gain access to the unit with keys or a remote control for the garage door.

- On 6 May 2021 a Holden Caprice with a missing bonnet was stolen from Southport (QP2100828601) this vehicle has not been recovered

Video footage from the complex has been reviewed and a Holden Colorado is seen to enter 10 mins before the vehicles are stolen. (Sch4p4(6))

A check with body coporate confirms that the same remote control was used multiple times by a person coming and going from the complex during the night as well as by the persons who steal the vehicles

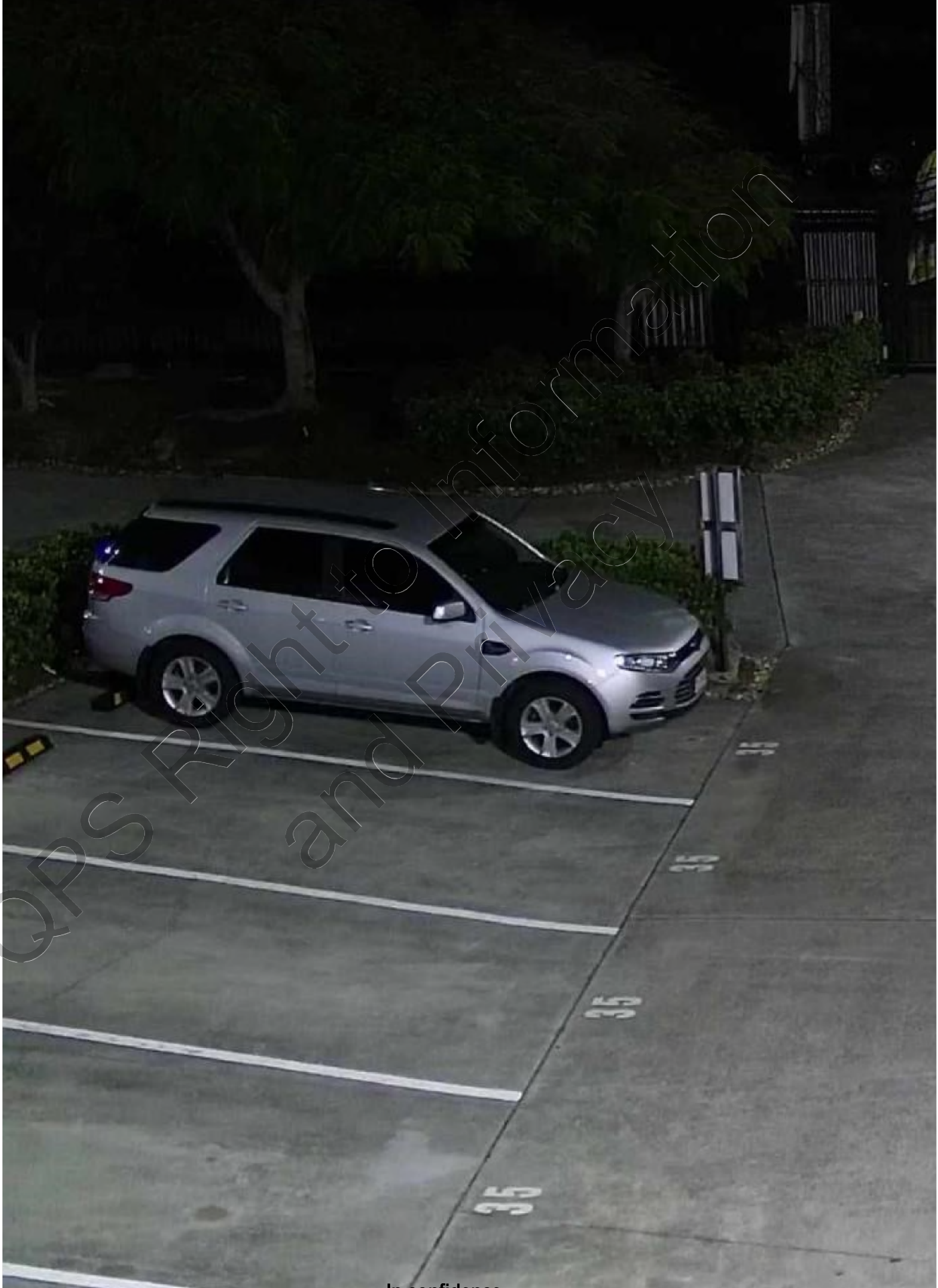
