IGNITION (STIPULATED A CIGARETTE OR SIMILAR) HAS BEEN PUT DOWN THE RUBBISH CHUTE AND THIS HAS CAUSED SPOT FIRED DOWN THE RUBBISH CHUTE ON DIFFERENT LEVELS. A LARGER FIRE HAS ALSO STARTED IN THE SKIP BIN ON THE GROUND FLOOR. THE FIRE APPEARS TO HAVE BEEN CONTAINED WITHIN THE REFUSE SYSTEM AND AT NO POINT WAS FIRE IN THE HALLWAYS OR IN INDIVIDUAL UNITS. THIS HAS FILLED THE CHUTE WITH SMOKE WHICH HAS SPREAD SMOKE INTO THE HALLWAY / COMMON AREA ON PRESUMABLY EVERY FLOOR. THIS HAS CAUSED AN EVACUATION OF THE BUILDING. QFRS WERE FIRST ON SCENE AND BEGAN THE EVACUATION OF THIS BUILDING. SEVERAL MEMBERS OF THE PUBLIC LINKED IN THIS REPORT HAVE BEEN TRIAGED AND TREATED BY QAS. THESE INJURIES WERE VARIED IN NATURE FROM PANIC ATTACK / SMOKE INHALATION / PHYSICAL INJURIES FROM FALLING OVER WHILE EVACUATING ON FOOT DOWN THE FIRE STAIRS. POLICE HAVE ATTENDED AND ASSISTED IN THE EVACUATION OF THE BUILDING AND CLOSING OF ROADS. DDO AND ON CALL INSPECTORS HAVE ATTENDED THIS SCENE. POLICE HAVE SPOKEN TO OFFICER IN CHARGE OF QFRS RESPONSE WHO INDICATED THAT THIS MATTER WAS NONSUSPICIOUS, AND THAT THE IGNITION OF THIS FIRE WAS NONSUSPICIOUS. QFRS SCIENTIFIC FIRE INVESTIGATORS ARE NOT GOING TO BE ATTENDING. DURING THIS INCIDENT MULTIPLE MEMBERS OF THE PUBLIC (30-50 PERSONS) HAVE APPROACHED POLICE INDICATING THAT ALTHOUGH THERE WAS A SIGNIFICANT SMOKE ON THEIR FLOORS THERE WAS NO AUDIBLE SMOKE/FIRE ALARM HEARD FROM THERE UNITS AND THEY SUSPECT THAT THE ALARM WAS FAULTY. A PERSON FROM LEVEL 7 INDICATED THAT UPON SEEING THE SMOKE IN THE HALLWAY THEY HAVE SMASHED THE "BREAK GLASS IN CASE OF FIRE" ALARM AND STILL NO AUDIBLE ALARM SOUNDED. THESE DETAILS HAVE BEEN PASSED ON TO QFRS FOR APPROPRIATE FOLLOW-UP. AFTER SEVERAL HOURS AT SCENE QFRS WERE HAPPY THAT THE VAST MAJORITY OF THE SMOKE HAS CLEARED, AND PERSONS WERE SAFE TO RETURN TO THEIR ROOMS. HEAVY MEDIA ATTENDANCE. FIRE REPORT MO DETAILS THE FIRE STARTED IN THE RUBBISH CHUTE, SOMEWHERE TOWARD THE TOP OF THE BUILDING.
